

FARSCCD

- 1 Saudi Arabia Update:
 - A To ensure fair labor conditions FARSCCD investigated the request to have two faculty members create curriculum.
 - B Upon investigation, it was determined that the RSCCD Foundation Board was in violation of the Brown Act.
 - C FARSCCD has filed suit for violations of the Brown Act.
- 2 Contract Negotiations
 - A 1.02% COLA from State and .53% to adjust for 9th for 1.55% counter was 1%
 - B FARSCCD offered to take down the 10% escalation clause to 8% with the addition of a 17 Step the district said no and take down escalation to 5%.
 - C Lab to lab, 1 to 1, is tentatively agreed to for the sciences and nursing classes.
 - D FARSCCD elections will soon take place.

Resource Request Process

- 1 Resource requests are initiated by a department.
- 2 Requests then go to chairs for ranking, then to joint chairs for ranking.
- 3 One time only requests seemed to be granted this year.
- 4 The issue seems to be the hiring of personnel; the process needs to be improved upon.
 - A Some believe that there is inequity in working conditions as they are understaffed.
 - B Direct impact on the classroom should perhaps be given priority.
 - C Personnel comes from the general funds and there has been no addition to general fund expenditures.
 - D Classified employees must also be consulted for personnel requests.
 - E It was suggested that these concerns be brought forth to PIE.

ACCJC Update

- 1 A task force from the Chancellor's Office has been created to address rectifying issues with the ACCJC.
- 2 Proposals include options from replacement to nothing.
- 3 If a new body was selected what would happen with current accreditations?
- 4 A plan is being proposed to be in place for transition by July 1, 2016.
- 5 This presupposes that another body would want to take on the responsibility.
- 6 The ACCJC is a private company and outside of public control.

Virtual Office Hours

- 1 Faculty are interested in replacing one of the five required office hours with a virtual office hour.
- 2 Faculty said this may allow for more equitable access.
- 3 Faculty could use CCCOnfer or BusnisSkype.

Instructional Calendars

- 1 Planning for instructional calendars is made less than one year in advance.
- 2 Faculty requested that the planning be more transparent and plan for multiple years.
- 3 Faculty requested that the semester offerings be looked upon, being more innovative.
- 4 Competition with other colleges demands this re-examination.

5 It was suggested that FLEX and the end of intersession could overlap.

Preferred Name

- 1 There is now a new column on faculty rosters: "Preferred Name"
- 2 Currently there will be nothing in this column and faculty must manually input the data.
- 3 In order for a student to make this official, they must submit a form with Admissions and Records.
- 4 Preferred names will not be granted capriciously.
- 5 Students that have a preferred name that want this name to appear on BlackBoard will need to be referred to Scott James.
