Whereas, Students continue to struggle with adapting to new instructional modalities, or experience difficulty balancing their education with other situations or obligations that have changed as a result of the COVID-19 crisis; and

Whereas, per Title 5 §58509, the COVID-19 pandemic falls into the category of extraordinary conditions and college may grant and excused withdrawal (EW) without requiring additional documentation;

Resolved, The Academic Senate of Santiago Canyon College encourage Admissions and Records to grant an Excused Withdrawal without documentation if students submit the request by June 10, 2022 for the 2022 Spring Semester;

Resolved, The Academic Senate of Santiago Canyon College encourage Admissions and Records to grant an Excused Withdrawal without documentation if students submit the request by August 12, 2022 for the 2022 Summer Semester; and,

Resolved, The Academic Senate of Santiago Canyon College encourage Admissions and Records to grant an Excused Withdrawal without documentation if students submit the request by December 16, 2022 for 2022 Fall Semester.
