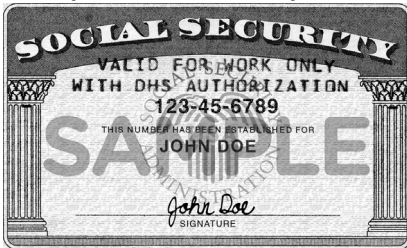
## SOCIAL SECURITY DISCREPANCY RESOLUTION FOR PARENT (2) (Father/Mother/Stepparent)

The first parent (**Parent #2**) you on listed your Free Application for Federal Student Aid (FAFSA) has their name, Social Security number (SSN), or date of birth that does not match with the Social Security Administration records. Please refer back to your FAFSA to determine which part of the information you listed for **Parent #2** is incorrect. Then you must update your FAFSA with the correct information by logging in to your FAFSA at [www.fafsa.gov](http://www.fafsa.gov) and clicking "Corrections on the Web." Be sure the information you are entering matches the information on your parent's SSN card. **You will not be eligible for financial aid funds until the discrepancy is resolved and your FAFSA has been reprocessed with the updated information.**

However, if the name, SSN and date of birth are correct on the FAFSA, you should contact the Social Security Administration to update their records with the correct information. The SSA can be contacted at 1-800-772-1314 or online at [www.ssa.gov](http://www.ssa.gov).

**Please Note:** If you used a Tax I.D. # in lieu of an SSN, or if your parent has an SSN that was issued for "work only" (see example below) **this is not considered an acceptable SSN and a correction must be made.** If your parent does not have an SSN, or a "work only" SSN, then all zeros must be reported on your FAFSA in place of of an SSN (Ex: 000-00-0000).
