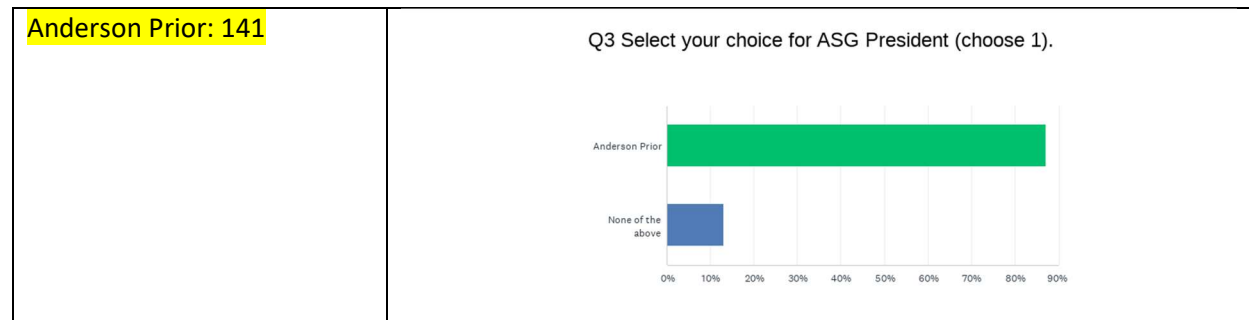

Total Ballots Disqualified: 3

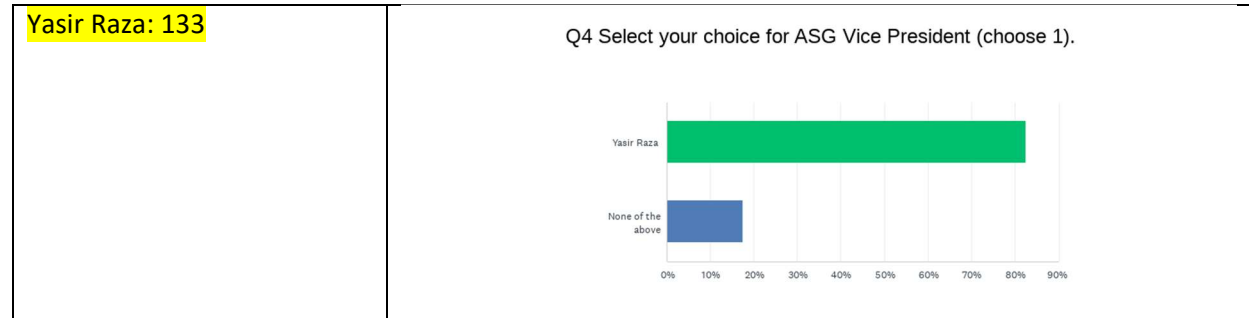

- If a candidate had the most votes but is not highlighted as the winning candidate, it is likely because they accepted a different position. Candidates were allowed to run for up to two (2) positions.
- In some contests where more than one position was available, the total number of votes cast may add up to more than the total number of voters. This is because voters were allowed to vote for more than one candidate, up to the number of available positions.

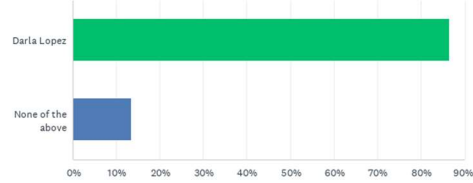

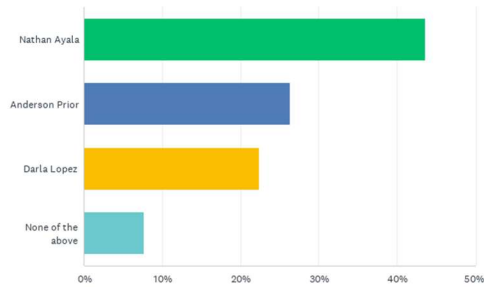
